

The SOVA CONFERENCE in Washington Feb 9-12 was A GREAT SUCCESS!

- 29 Participants From 14 States Attended the Conference
- We agreed to support House Resolution (HR) 701, a statement of principle by House Members for fully funding and staffing VA healthcare and not dismantling the VHA. (See Page 5 for More Info.)
- We decided to lobby to get as many House Members as possible to join the 8 members who are already Co-Sponsors of HR 701.
 - We met with 33 Members of Congress (MOC) or their staff and urged them to Co-Sponsor HR 701.
 - As a result of our advocacy, two House Members -- Rep Alexandria Ocasio-Cortez (D-NY, 14th) and Rep Adriano Espaillat (D-NY, 17th) – became Co-Sponsors of HR 701.
- We return to our communities to rally our supporters and allies to join us in urging House members to step up and become Co-Sponsors of HR 701.

While we were in Washington, we videoed veterans who depend on the VA for their healthcare. 

REPORT ON THE FIRST NATIONAL SOVA CONFERENCE, WASHINGTON, DC, FEB 9-12



VISIT TO AFGE'S VA COUNCIL MEETING: Early Sunday morning a dozen of us arrived in DC to appear at the AFGE's Legislative Conference where the VA Council was meeting. We were recognized and solidarity was expressed by representatives of the VA unions serving our brothers and sisters working at VA hospitals.

FIRST MEAL AND INTRODUCTIONS: The SOVA Conference opened Sunday night, Feb. 9, with a dinner meal prepared by Conference Chef Liz Wiesen and volunteer helpers. (A system of KP duty was established to deliver the 11 meals for participants during the Conference.) After dinner we went around the room and introduced ourselves to other Conference participants.

PREPARING FOR LOBBYING: Tuesday morning we continued our training and preparation for lobbying. Conference participants divided into three Lobbying Teams (#1, #2, #4 – no #3). Each Team began reviewing what we were asking MOC to do for us, assigning roles for each member of the Team and practicing working together.

LOBBYING MEMBERS OF CONGRESS: Tuesday afternoon, Feb 11, and Wednesday, Feb 12, were devoted to lobbying Members of Congress (MOC). We concentrated on House members. We had meetings with 11 Conference participants' MOC and 22 (13 Democrats & 9 Republicans) members of the House Committee on Veterans Affairs. Our message to all was to Stop Privatization of VA Healthcare and become Co-Sponsors of H.Res.701 Expressing support for policies that maintain a robust, fully funded and staffed Veterans Health Administration of the Department of Veterans Affairs and do not jeopardize care for veterans by moving essential resources to the for-profit private sector.
